In consideration of payment of the license fee provided for above, the Licensor, i.e. The Producer of the FILM, will provide the Licensee with one copy of a dvd to be used for the screening, and electronic publicity materials within 30 days.

- The Licensee hereby expressly agrees that the FILM shall be used only for non-commercial purposes, as set forth in this agreement and no other purpose. .... (Initial here)
- The Licensee hereby agrees that permission for additional exhibition dates must be made to the Licensor by email, info@NormalIsOverTheMovie.com, and that additional licensee fees will be incurred. .... (Initial here)
- The Licensee agrees that the film may not be exhibited before an audience, where admission is charged for viewing the film. .... Initial here)  
If Licensee intends to charge an entrance fee, Licensee is obliged to contact Licensor at info@NormalIsOverTheMovie.com in order to purchase Public Performance Rights.
- The Licensee agrees that when purchasing a film at the educational rate, Licensee is granted PPR, which entitles Licensee to show the FILM to a public audience where no admission fees are charged. This right does not apply when the FILM is purchased at home use rate..... (Initial here)
- No refunds will be issued. If a DVD is received damaged or in unsatisfactory condition, it may be exchanged for a new copy of the same film. Damages must be reported within 14 days of receipt of the FILM.
- The Licensee agrees that it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised, or made available online, nor distribute it by any future technologies or to any other party not contained herein at any time or in any manner other than as provided for in this AGREEMENT. .... - This agreement shall not be assigned by Licensor to any person without the written consent of Telekan cc, the Licensor.

With respect to the license granted hereunder, it is expressly understood and acknowledged by the Licensee that any rights, title, or interest that the Licensor maintains with respect to the FILM, are expressly reserved by the Licensor. This agreement constitutes the entire understanding of the parties with respect to the subject matter hereof, and any amendments, changes or modifications, shall have legal effect and be binding only if made in writing and signed by both parties.
